Old Business

1. Bylaw revisions
 - All proposed changes were reviewed and discussion offered. Additional changes discussed were adding that funds can be deposited with the treasurer or into the deposit box, and that receipts must be submitted to the Treasurer within 30 days (instead of 15). Both these changes were discussed, motion made to add these changes to the bylaws. Motion carried. Remainder of bylaw amendments were voted on by ballot. Results: all revisions were accepted.
2. Athletics Update
